Freeport-McMoRan Copper & Gold Inc. announced today that it has completed the sale of its international wire and cable business, operated in the name of Phelps Dodge International Corporation, to General Cable Corporation (NYSE:BGC) for \$735 million (see Exhibit 99.1). FCX expects to use the proceeds estimated to approximate \$620 million, net of taxes and other transaction costs, to repay debt.
