- (1) On December 18, 2007, Mr. Sandhu received a grant of 100,000 shares of Restricted Stock Units ("RSU") that represented a contingent right to receive one share of the Company's Common Stock. The RSUs were granted pursuant to the 2004 Stock Incentive Plan and previously reported as acquired on Table I on a Form 4 dated December 18, 2007. On June 18, 2008 in accordance with the terms of the RSU agreement, 1/8 of those shares vested and the Company withheld an equivalent amount of RSUs at fair market value to pay the minimum tax withholding requirements for Mr. Sandhu.
