- (1) These shares are held by the reporting person's spouse and are represented in Table I in the form of Restricted Stock Units ("RSUs") that represent a contingent right to receive one share of the Company's common stock. The RSUs were granted pursuant to the Company's 2004 Stock Incentive Plan which the reporting person's spouse is eligible to participate in and are subject to the terms and conditions of the Plan and the applicable award agreement. These shares are subject to the following vesting requirements: 1/8 of the grant will vest on June 18, 2010 and thereafter every six months over the remaining 4 year period until all such RSUs are vested on 12/18/13. The reporting person disclaims beneficial ownership of common stock held by his spouse. The filing of this statement shall not be deemed to be an admission that the reporting person is the beneficial owner of any securities for purposes of Section 16 of the Securities Exchange Act of 1934, as amended, or otherwise.
