(1) On July 8, 2015, the reporting person was granted performance restricted stock units, the vesting of which was subject to both continued service and the degree to which a relative Total Shareholder Return target was attained for the period July 8, 2015 to March 31, 2018. The Compensation Committee certified that the payout for this award would be 189% (out of a possible 200%) of the target to the reporting person based on the degree to which Trimble performed against the S&P 500.

(2) On November 6, 2015, the reporting person was granted performance restricted stock units, the vesting of which was subject to both continued service and the degree to which a relative Total Shareholder Return target was attained for the period November 6, 2015 to March 31, 2018.
