The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Issuer: JPMorgan Chase Financial Company LLC.

Guarantor: JPMorgan Chase & Co.

Minimum Denomination: \$1,000

Indices: S&P 500 Index and Russell 2000 Index

Pricing Date: December 21, 2018

Observation Date: December 26, 2023

Maturity Date: December 29, 2023

Contingent Minimum Return: At least 35.00%\*

Contingent Buffer Amount: 30.00%

Payment At Maturity: If the Final Value of each Index is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{greater of (a) the Contingent Minimum Return and (b) the Lesser Performing Index Return})$

If the Final Value of the Lesser Performing Index is equal to its Initial Value or is less than the Initial Value by up to the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Absolute Index Return of the Lesser Performing Index})$

If the Final Value of the Lesser Performing Index is less than its Initial Value by more than the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return})$

If the Final Value of the Lesser Performing Index is less than its Initial Value by more than the Contingent Buffer Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.
