The Company has engaged Bank of America Merrill Lynch to market for sale roughly 43,000 net acres of the Marcellus shale position in McKean and Potter counties, Pennsylvania. The Company has also engaged Albrecht & Associates, Inc. to market for sale a package of non-core oil and gas properties. A copy of the press release is furnished as Exhibit 99.1 to this report.
