The following constitutes Amendment No. 5 to the Schedule 13D filed by the undersigned on November 2, 2015, and amended on January 9, 2017, on June 15, 2017, on November 17, 2017 and on April 20, 2018. This Amendment No. 5 amends the Schedule 13D as specifically set forth herein.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 is hereby amended and restated to read as follows:

The aggregate purchase price of the 760,322 shares owned by 180 Degree Capital Corp. ("180") is approximately \$4.9 million. Such shares were acquired in multiple private placement financings and in the initial public offering of Adesto Technologies Corporation (the "Issuer").

Item 5. Interest in Securities of the Issuer

Item 5(a)-(c) is hereby amended and restated in its entirety as set forth below:

(a)-(b) The aggregate percentage of Common Stock reported owned by each person named herein is based upon 21,454,826 shares of common stock outstanding as of May 2, 2018, as reported on the Issuer's quarterly report filed on Form 10-Q on May 10, 2018. As of May 21, 2018, 180 beneficially owned 760,322 shares of Common Stock, constituting approximately 3.5% of the shares outstanding of the Issuer. Mr. Rendino and Mr. Wolfe may be deemed to have shared voting and dispositive power over the Common Stock owned by 180 as a result of Mr. Rendino's position as Chief Executive Officer and Portfolio Manager of 180 and Mr. Wolfe's position as President and Portfolio Manager of 180. Mr. Wolfe and Mr. Rendino disclaim beneficial ownership of the shares owned by 180.

(c) Schedule A annexed hereto lists all the transactions in the Common Stock that were effected since April 20, 2018, which was the date of the most recent filing on Schedule 13D. All of such transactions related to the Common Stock were effected in the open market.
