Mr. Cohen controls each of Point72 Capital Advisors Inc., Cubist Systematic Strategies, and CPV Holdings. By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) Point72 Asset Management, Point72 Capital Advisors Inc., and Mr. Cohen may be deemed to beneficially own 188,700 Shares (constituting approximately 0.5% of the Shares outstanding); (ii) Cubist Systematic Strategies and Mr. Cohen may be deemed to beneficially own 181 Shares (constituting less than 0.1% of the Shares outstanding); and (iii) CPV Holdings and Mr. Cohen may be deemed to beneficially own 1,084,417 Shares (constituting approximately 3.1% of the Shares outstanding).
