- Pursuant to the terms of the Exchange Agreement dated as of August 5, 2015 by and among the Company, Pla-Fit Holdings, LLC and the holders from time to time of Holding Units and shares of Class B common stock, the holders thereof may exchange all or a portion of their Holding Units (along with an equal number of shares of Class B common stock) for shares of Class A common stock of the Company on a one-to-one basis. The Holding Units do not expire and the holders thereof are not required to pay an exercise price in connection with exchanges. The Class B common stock provides the holder with one vote on all matters submitted to a vote of the Company's stockholders but does not entitle the holder to any of the economic rights associated with shares of the Company's Class A common stock.
- (3) Represents 5,367,695 Holding Units and 5,367,695 shares of Class B common stock held by The Marc Grondahl Revocable Trust of 2006, u/d/t 06/01/06. Mr. Grondahl disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
