Item 4.

Purpose of Transaction.

Item 4 is hereby amended to add the following:

On March 26, 2009, Mark Schwarz, Hallmark's Executive Chairman, delivered a letter to Courtney Smith, the Company's Chairman and Chief Executive Officer, expressing Mr. Schwarz's interest in meeting with members of the Company's Board of Directors consistent with the suggestion of Mr. Smith to Mr. Schwarz on March 2, 2009. A copy of the letter is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
