As of the close of business on August 2, 2010, (i) Lion Fund owned directly 502,900 shares of Common Stock and (ii) Biglari Holdings owned directly 3,120,768 shares of Common Stock.

BCC, as the general partner of Lion Fund, may be deemed to beneficially own the 502,900 shares of Common Stock owned directly by Lion Fund.

BCC is a wholly-owned subsidiary of Biglari Holdings. Accordingly, Biglari Holdings may be deemed to beneficially own the 502,900 shares of Common Stock owned directly by Lion Fund.

Sardar Biglari is the Chairman and Chief Executive Officer of each of BCC and Biglari Holdings and may be deemed to control such entities. Accordingly, Sardar Biglari may be deemed to beneficially own the 502,900 shares of Common Stock owned directly by Lion Fund and the 3,120,768 shares of Common Stock owned directly by Biglari Holdings.
