On January 17, 2007, the Company granted 5,000 restricted shares, as an annual grant to non-employee directors, valued at the then current market price of \$7.14 per share. Such shares vest on January 17, 2008 unless the reporting person ceases to be a director prior to the vesting date.
- (2) Options expire on such date unless reporting person ceases to be a director, in which event options expire four years from date of reporting person's directorship ends.
- (3) Such options vested ratably over 2001.
