The filing of this Schedule 13G by each Filer should not be construed as an admission that it is, and each Filer disclaims that it is, the beneficial owner of any shares of the Stock reported on this Schedule 13G, except to the extent of its pecuniary interest therein. WC Offshore is filing jointly with the other Filers, but not

as a member of a group, and it expressly disclaims membership in a group.
