**TELECOM ITALIA SUCCESSFULLY PRICES 500 MILLION EURO 6-YEAR BOND ISSUE**

**The issue will take place via private placement**

*Milan, 13 July 2007* - Telecom Italia today successfully priced a floating-rate bond issue for a total value of 500 million Euro and with maturity in July 2013.

With this operation, Telecom Italia has taken the opportunity to re-finance maturing debt and reduce its average overall cost.

The terms set for the issue are as follows:

issuer: Telecom Italia S.p.A.

issue date: 19 July 2007

maturity: 19 July 2013

•

duration: 6 years

•

coupon: Euribor 3 month +0.63% payable quarterly

The operation which took the form of a *private placement* is part of Telecom Italia's 15 billion euro Euro Medium Term Note (EMTN) programme.

The issue will be quoted on the Luxembourg stock exchange.
