The investment management companies, which include a "bank" as defined in Section 3(a)(6) of the Securities Exchange Act of 1934 (the "Act") and several investment advisers registered under Section 203 of the Investment Advisers Act of 1940, provide investment advisory and management services for their respective clients which include registered investment companies and institutional accounts. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 21,707,800 shares or 8.7% of the 249,347,474 shares of Common Shares believed to be outstanding.

Capital International, Inc., an investment adviser registered under Section 203 of the Investment Advisers Act of 1940 is deemed to be the beneficial owner of 21,628,100 shares or 8.7% of the 249,347,474 shares of Common Shares believed to be outstanding as a result of acting as investment adviser to various investment companies and institutional accounts.

Emerging Markets Growth Fund, Inc., an investment company registered under the Investment Company Act of 1940, which is advised by Capital International, Inc., is the beneficial owner of 17,189,000 shares or 6.9% of the 249,347,474 shares of Common Shares believed to be outstanding.
