Capital Group International, Inc. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 8,001,420 shares or 2.4% of the 336,066,607 shares of Ordinary Shares, including American Depositary Shares, believed to be outstanding.
