The investment management companies, which include a "bank" as defined in Section 3(a) (6) of the Securities Exchange Act of 1934 (the "Act") and several investment advisers registered under Section 203 of the Investment Advisers Act of 1940, provide investment advisory and management services for their respective clients which include registered investment companies and institutional accounts. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 15,338,690 shares or 3.9% of the 55,636,297 shares of Class D Shares, including American Depository Shares, believed to be outstanding.

Capital International, Inc., an investment adviser registered under Section 203 of the Investment Advisers Act of 1940 is deemed to be the beneficial owner of 15,338,690 shares or 3.9% of the 55,636,297 shares of Class D Shares, including American Depository Shares, believed to be outstanding as a result of acting as investment adviser to various investment companies and institutional accounts.

All of the shares reported are held in the form of American Depository Shares, which each represent 7 Class D Shares of Common Stock.
