### ASE TO ACQUIRE EEMS TEST SINGAPORE FROM EEMS

Taipei, Taiwan, R.O.C., August 2, 2010 - Advanced Semiconductor Engineering, Inc. (TAIEX: 2311, NYSE: ASX) (hereinafter "ASE", or the "Company") announced today that it has entered into a definitive agreement ("Sale and Purchase Agreement") with EEMS Asia Pte Ltd. ("EEMS Asia"), a subsidiary of EEMS Italia S.p.A, pursuant to which ASE has agreed, subject to the terms of the Sale and Purchase Agreement, to acquire 100% interest in EEMS Test Singapore Pte Ltd. ("EEMS Test Singapore") for an enterprise value of approximately US\$67.7 million.
