If the final underlying value is **less than** the initial underlying value by an amount **less than or equal to** the buffer amount:

$\$1,000$

If the final underlying value is **less than** the initial underlying value by an amount **greater than** the buffer amount:

$$\$1,000 + [\$1,000 \times (\text{the underlying return} + \text{the buffer amount})]$$
