FLOATING RATE CONVERTIBLE SENIOR DEBENTURES DUE DECEMBER, 2035

This prospectus supplement updates and amends certain information contained in the prospectus dated March 10, 2006, as supplemented by a prospectus supplement dated April 13, 2006, by prospectus supplement No. 2 dated July 13, 2006, by prospectus supplement No. 3 dated October 13, 2006, by prospectus supplement No. 4 dated January 12, 2007, by prospectus supplement No. 5 dated April 12, 2007 and by prospectus supplement No. 6 dated July 13, 2007, relating to the offer and sale from time to time by certain selling securityholders of up to \$2,000,000,000 aggregate principal amount of our Floating Rate Convertible Senior Debentures due December, 2035 and any shares of common stock issuable upon conversion of the debentures. The terms of the debentures are set forth in the prospectus and any supplements or amendments thereto. This prospectus supplement should be read in conjunction with, and may not be delivered or utilized without, the prospectus, the prospectus supplement dated April 13, 2006, and any amendments or supplements thereto. This prospectus supplement is qualified by reference to the prospectus, the prospectus supplement dated April 13, 2006, and any amendments or supplements thereto, except to the extent that the information in this prospectus supplement supersedes the information contained in the prospectus, the prospectus supplement dated April 13, 2006, or in any amendments or supplements thereto. The terms of the debentures are set forth in the prospectus and the prospectus supplement dated April 13, 2006.

The securities offered hereby involve significant risks and uncertainties. These risks are described under the caption Risk Factors beginning on page S-5 of the prospectus supplement dated April 13, 2006. You should consider these Risk Factors before purchasing these securities.

The debentures are not deposits or other obligations of a depository institution and are not insured by the Federal Deposit Insurance Corporation, The Bank Insurance Fund or any other governmental agency. Neither the Securities and Exchange Commission nor any state securities commission has approved or disapproved of these securities or determined if this prospectus supplement is truthful or complete. Any representation to the contrary is a criminal offense.

more than 1% of our outstanding common stock after the offering by such securityholder.
