**Item 1.01. Entry into a Material Definitive Agreement**

On March 17, 2006, Gladstone Commercial Corporation (the Company ) amended its line of credit which was originally established on February 28, 2005, and previously amended on April 21, 2005 and July 6, 2005, to increase the current maximum availability of credit under the line from \$60 million to \$75 million. The line of credit was arranged by BB&T Capital Markets, with Branch Banking and Trust Company acting as agent, and includes syndicate participations by First Horizon Bank and Compass Bank.

As of March 22, 2006, we may draw up to an aggregate of \$62.9 million under this agreement, of which we have aggregate borrowings outstanding under the line of credit of \$35.3 million.
