As of the date hereof, Jack Silver beneficially owns 1,316,178 shares of common stock of the Issuer (the "Shares"), representing approximately 3.5 % of the Shares outstanding, including: (i) 962,478 Shares held by the Sherleigh Associates Profit Sharing Plan, a trust of which Mr. Silver is the trustee; and (ii) 353,700 Shares held by the Sherleigh Associates Defined Benefit Pension Plan, a trust of which Mr. Silver is the trustee.

Mr. Silver has the sole voting and dispositive power with respect to all of the Shares beneficially owned by him.
