This Amendment No. 18 amends and supplements the Tender Offer Statement on Schedule TO, filed with the Securities and Exchange Commission (“SEC”) on February 2, 2007 and amended thereafter (as so amended, the “Schedule TO”). The Schedule TO relates to the offer by Weyerhaeuser Company (“Weyerhaeuser”) to exchange all shares of common stock, par value \$0.01 per share, of Domtar Corporation, a Delaware corporation (“Domtar Corporation common stock”), which are owned by Weyerhaeuser, for common shares of Weyerhaeuser, par value \$1.25 per share (“Weyerhaeuser common shares”), and exchangeable shares of Weyerhaeuser Company Limited (“Weyerhaeuser exchangeable shares”), each of which is exchangeable for one Weyerhaeuser common share, that are validly tendered and not properly withdrawn prior to the expiration of the exchange offer, upon the terms and subject to the conditions set forth in the Prospectus—Offer to Exchange, dated February 12, 2007, the applicable Letters of Transmittal and the instructions thereto (which, together with any amendments or supplements thereto, collectively constitute the “Exchange Offer”). Except as specifically provided herein, this Amendment does not modify any of the information previously reported on the Schedule TO.

Item 4. Terms of the Transaction.

(a) Material terms

The Exchange Offer expired at 12.00 midnight, New York City time, on March 6, 2007.

On March 7, 2007, Weyerhaeuser announced that:

- (i) Weyerhaeuser has accepted a total of 25,490,196 Weyerhaeuser common shares and Weyerhaeuser exchangeable shares in exchange for 284,067,852 shares of Domtar Corporation common stock;
- (ii) according to the exchange agent and the Canadian depository for the Exchange Offer, a total of 116,470,356 Weyerhaeuser common shares and Weyerhaeuser exchangeable shares were validly tendered and not withdrawn prior to the expiration of the Exchange Offer, including 62,236,630 shares tendered pursuant to guaranteed delivery procedures;
- (iii) the total shares tendered includes 181,122 Weyerhaeuser common shares and Weyerhaeuser exchangeable shares tendered by odd lot shareholders not subject to proration; and
- (iv) the exchange of shares of Domtar Corporation common stock for Weyerhaeuser common shares and Weyerhaeuser exchangeable shares will be subject to proration: based on the total number of Weyerhaeuser common shares and Weyerhaeuser exchangeable shares reported to be tendered prior to the expiration of the Exchange Offer, it is estimated that approximately 21.76 percent of the Weyerhaeuser common shares and Weyerhaeuser exchangeable shares validly tendered will be accepted for exchange.
