Dear customer,

On 01 June 2017 we announced that we have agreed with Praxair on a binding Business Combination Agreement for a merger of equals between our companies.

This is a very important result. However, the consummation of the transaction is subject to shareholder and regulatory approvals and other customary closing conditions.

Linde will continue to honour the relationships with its customers and deliver products and services of the highest quality. With the transaction we are striving to create a network that enables more efficiency, best-in-class processes, shorter delivery times and a broader offer of products and services for our customers.

Following Closing, Linde would ensure a seamless transition process for our customers. Until Closing, Linde and Praxair will remain two separate companies and competitors. Please note that until the transaction is approved by regulatory bodies and closed, any alignment between Linde and Praxair (e.g. joint offers) can only be extended in very exceptional cases and after being subject to strict legal scrutiny.

The merger process is governed by strict legal requirements and is observed very closely by relevant regulatory authorities. We therefore kindly ask for your understanding that, at this point, communication on the potential merger has to be limited to the points contained the formal announcement. #### Additional Information and Where to Find It

In connection with the proposed business combination between Praxair, Inc. (“Praxair”) and Linde AG (“Linde”), Zamalight PLC (“New Holdco”) is expected to file a Registration Statement on Form S-4 with the U.S. Securities and Exchange Commission (“SEC”) that will include (1) a proxy statement of Praxair that will also constitute a prospectus for New Holdco and (2) an offering prospectus of New Holdco to be used in connection with New Holdco’s offer to acquire Linde shares held by U.S. holders. When available, Praxair will mail the proxy statement/prospectus to its stockholders in connection with the vote to approve the merger of Praxair and an indirect wholly-owned subsidiary of New Holdco, and New Holdco will distribute the offering prospectus to Linde shareholders in the United States in connection with New Holdco’s offer to acquire all of the outstanding shares of Linde. New Holdco is also expected to file an offer document with the German Federal Financial Supervisory Authority (Bundesanstalt fuer Finanzdienstleistungsaufsicht) (“BaFin”). The consummation of the proposed business combination is subject to regulatory approvals and other customary closing conditions.
