growth at May 31, 2005, and year-over-year loan growth at May 31, 2005. This information was expressed in terms of percentage growth.

Because of a misleading research note issued, which suggests that the Company has experienced zero deposit growth and zero loan growth in the first two months of the second quarter, the Company is pleased to provide the correct information.
