Assuming continued employment, the Restricted Stock Units held by the Reporting Person will vest and be paid out as follows: 20,869 on November 2, 2015; 26,624 on November 16, 2015; 23,175 on October 31, 2016; 15,686 on October 31, 2017; and 8,217 on October 31, 2018. Upon payout, shares will be withheld to cover minimum statutory tax obligations. Restricted Stock Units are accompanied by dividend equivalent rights that will be payable in cash at the time of payout of the related shares.
