- (4) 373 of 1,867 RSUs granted on October 19, 2015 vest on each of October 19, 2016, October 19, 2017, October 19, 2018. An additional 374 of these RSUs vest each on October 19, 2019 and October 19, 2020, provided that the Reporting Person remains continuously employed by the Issuer through each applicable vesting date. The vested shares will be delivered to the Reporting Person upon vesting.
