Entry into a Material Definitive Agreement.

On December 17, 2010, the Registrant and Samsung Mobile Display Co., Ltd. (“SMD”) entered into Amendment No. 4 to their OLED Patent License Agreement dated as of April 19, 2005, as previously amended (the “Agreement”).
