### ITEM 4.01 CHANGES IN REGISTRANT'S CERTIFYING ACCOUNTANT.

On February 18, 2009, Global Resource Corporation (the "Company") appointed Rothstein Kass & Company, P.C. ("Rothstein Kass") as the Company's independent registered public accounting firm.

The decision to appoint Rothstein Kass was recommended and approved by the Audit Committee of the Board of Directors of the Company.

Prior to the engagement of Rothstein Kass, the Company did not consult with such firm regarding the application of accounting principles to a specific completed or contemplated transaction, or any matter that was either the subject of a disagreement or a reportable event as described in paragraph (a)(1)(v) of item 304 of Regulation S-K. The Company also did not consult with Rothstein Kass regarding the type of audit opinion which might be rendered on the Company's financial statements and no oral or written report was provided by Rothstein Kass.
