(SSF3) and Special Situations Fund III QP, L.P.* (SSFQ). (SSF3, SSFQ and Cayman will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.
