This is a joint filing by Austin W. Marxe (Marxe) and David M. Greenhouse (Greenhouse). They share voting and investment control over all securities owned by Special Situations Fund III QP, L.P. (QP) and Special Situations Private Equity Fund, L.P. (PE), respectively. 1,150 of Preferred Stock are convertible into 718,750 shares of Common Stock are held by QP and 3,750 Preferred Stock are convertible into 2,343,750 shares of Common Stock are held by PE. The interest of Marxe & Greenhouse in the shares of Preferred Stock owned by QP and PE is limited to the extent of his pecuniary interest.
