**Disclosure according to Art. 28 of the AR EU based on the revised Stock Exchange Ordinance**

Zurich, July 5, 2007 **Credit Suisse Group's own holdings of equity securities exceeded the disclosure threshold of 15% of voting rights entered in the Commercial Register on July 1, 2007. Its holdings comprised 221,475,735 registered shares and options, which correspond to 18.23% of voting rights. This includes 5.64% of own shares that were purchased during share buyback programs and are due to be cancelled. This disclosure notification is being made on the basis of the new calculation model that entered into effect on July 1, 2007, and forms part of the Ordinance of the Federal Banking Commission (FBC) on Stock Exchanges and Securities Trading.**

The amendment to the Ordinance of the FBC on Stock Exchanges and Securities Trading that entered into effect on July 1, 2007, alters the basis for the calculation of the disclosure requirement and stipulates that conversion rights, share acquisition rights and share sale rights must be taken into account when disclosing holdings of own shares. The previous 5% exemption limit has been abolished. Following the entry into force of the revised Ordinance, the own holdings of Credit Suisse Group, Paradeplatz 8, 8001, Zurich, exceeded the disclosure threshold of 15% prescribed in Art. 28 of the Additional Rules for Listing in the SWX EU-Compatible Segment (AR EU).

Credit Suisse Group's total own holdings on July 1, 2007, amounted to 221,475,735 shares and options, which correspond to 18.23% of voting rights. This comprised 172,120,175 million registered shares (14.17% of voting rights), of which 68,509,000 registered shares (5.64% of voting rights) were purchased during two share buyback programs and are due to be cancelled. The remaining 103,611,175 registered shares (8.53% of voting rights) will be retained to satisfy obligations relating to employee participation plans as well as for trading purposes.

The own holdings of 18.23% of voting rights that were disclosed also include share acquisition rights in the amount of 27,047,437 (2.22% of voting rights) and share sale rights in the amount of 22,308,123 (1.84% of voting rights).
