(1) Each of the options to purchase shares of the Company's common stock is granted effective as of January 6, 2016 and made pursuant to the Company's 2013 Stock Incentive Plan. The exercise price is \$2.88 per share, which is equal to the closing price of the Company's common stock on the Nasdaq Capital Market on January 6, 2016. Subject to the named executive officer's continued employment with the Company on the applicable vesting date, the option vests with respect to 25% of the underlying shares on the first anniversary of the date of grant and the balance of the underlying shares vest in twelve equal quarterly installments following the first anniversary of the date of grant.
