Devaney controls UREVI and UCMHI and therefore may be deemed to be the beneficial owner of the 1,624,694 shares of Ocwen's common stock owned directly and indirectly by UREVI and UCMHI. Devaney may also be deemed to be the beneficial owner of 5,194,517 shares of Ocwen's common stock controlled personally and through retirement accounts. All figures are as of December 31, 2016.
