(1) On February 17, 2010 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 7,336 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 17, 2012, 3,668 shares of the originally granted RSAs vested, of which 1,308 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.

(2) Between May 25, 2011 and February 21, 2012 the Reporting Person acquired 25 shares of First Midwest Bancorp, Inc. Common Stock pursuant to the under the First Midwest Bancorp, Inc. Dividend Reinvestment Plan . The information in this report is based on a plan

statement dated December 16, 2011.

(3) Between May 25, 2011 and February 21, 2012 the reporting person acquired 20 shares of First Midwest common stock pursuant to the dividend reinvestment feature under the First Midwest Bancorp, Inc. Non-Qualified Gain Deferral Plan. The information in this report is based on a plan statement dated January 17, 2012.

(4) Pursuant to a statement dated December 15, 2011, reflects 14 shares sold from the Reporting Person's account under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan in satisfaction of quarterly Plan administration fees.

Between May 25, 2011 and February 21, 2012 the Reporting Person acquired the following shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan: (a) 73 shares pursuant to quarterly match contributions from the Company; (b) 47 shares pursuant to the Dividend Reinvestment feature of the Plan; and (c) 171 shares pursuant to payroll contributions.
