On December 19, 2007, Peace Arch announced that it has entered into a non-binding Letter of Intent with London-based film and television sales company ContentFilm plc (AIM: CFL) ( ContentFilm ) in which Peace Arch has indicated that it is considering making an offer for all of the issued and to be issued ordinary share capital of ContentFilm for a cash consideration of GBP 0.20 per ordinary share of GBP 0.01 each ( Ordinary Share ) or, at the election of each holder, 0.2 Peace Arch common shares for each Ordinary Share up to a total of 19,500,000 PAE Common Shares (the Share Alternative ). Assuming elections are made to take up the Share Alternative in full, the total cash payable would be approximately \$35,000,000.00.

**Immediately fortify key operational areas through anticipated synergies and efficiencies**

TORONTO--(MARKET WIRE) December 19, 2007 - Peace Arch Entertainment Group Inc. (AMEX:PAE - News) (Toronto:PAE.TO - News) ( PAE ), an integrated global entertainment company creating and acquiring critically acclaimed film, television and DVD content for worldwide distribution, today announced that it has entered into a non-binding Letter of Intent with London-based film and television sales company ContentFilm plc (AIM: CFL) ( ContentFilm ) in which PAE has indicated that it is considering making an offer for all of the issued and to be issued ordinary share capital of ContentFilm for a cash consideration of GBP 0.20 per ordinary share of GBP 0.01 each ( Ordinary Share ) or, at the election of each holder, 0.2 PAE common shares for each Ordinary Share up to a total of 19,500,000 PAE Common Shares (the Share Alternative ). Assuming elections are made to take up the Share Alternative in full, the total cash payable would be approximately \$35,000,000.00.

ContentFilm has 174,027,323 Ordinary Shares in issue, 17,169,998 in the money options and 3,048,518 in the money warrants. Any PAE shares issued as part of this transaction will be subject to a twelve-month lock-up period. In addition, the 34,840,262 Convertible Redeemable Preference Shares in ContentFilm will be rolled over into a similar instrument of PAE at a ratio of 5:1, for a total of 6,968,052 Convertible Redeemable Preference Shares of PAE with a redemption price of C\$2.60 and a redemption date of June 2010.

The Letter of Intent is non-binding (save for the provisions relating to exclusivity and confidentiality) and is subject to various conditions, including negotiation and execution of definitive financing agreements, formal offer conditions, at least 50% of the shareholders of ContentFilm entering into irrevocable undertakings or letters of intent to accept the Share Alternative, completion of due diligence by both parties and approval by the Board of Directors of each entity. Peace Arch reserves the right to waive these conditions should they not be satisfied. This announcement does not constitute a firm intention to make an offer by PAE under Rule 2.5 of the City Code on Takeovers and Mergers (the Code ). Accordingly, there can be no certainty at this time that PAE will proceed with the making of an offer for ContentFilm even if these conditions are satisfied, or that any offer made will be successful.

Content operates through three divisions:

§

ContentFilm International is the film sales and finance arm of ContentFilm. It specializes in high quality and commercial feature films, assisting the film's producer in securing finance and then marketing and selling the film internationally. The company's latest productions include *Closing the Ring*, directed by Lord Attenborough and starring Shirley MacLaine, Christopher Plummer and Mischa Barton, *Black Book* directed by Paul Verhoeven, *Thank You for Smoking* and the acquisition of worldwide rights to *Outpost*.

Fireworks International is ContentFilm's film and television library sales division with over 2,000 hours of programming including motion pictures, primetime and children's TV series, mini-series and made-for-television films. It specializes in assisting TV producers to finance their programming and then marketing and selling the programs throughout the world in the traditional media and on digital platforms. Historically its content has included commercial and high-quality multi-episodic programming produced in the USA and Canada. New series of this nature include the comedy drama *The Jane Show*, the mystery drama series *Whistler* and children's series *Young Dracula*.

Allumination FilmWorks is ContentFilm's DVD distribution arm in the U.S. Allumination acquires domestic home entertainment rights from studios and independent producers and distributes DVDs of its licensed content to retailers throughout the U.S. Additionally, it acquires satellite and cable television rights as well as international theatrical and home entertainment rights and sells those rights on to other domestic and international distributors. It also distributes audio product under the American Beat Records label. Allumination has a portfolio of approximately 700 quality titles in all major categories including various music specials and children's/family feature titles and its titles include *The Saddle Club*, *Hip Hop Harry* and *Judge Judy-Justice Served*.

Peace Arch's proposed acquisition of ContentFilm would create an asset-rich, vertically integrated film, television and home entertainment company with significant strengths in Canada, the United States and abroad, said Jeff Sagansky, Chief Executive Officer of Peace Arch. A successful conclusion to the acquisition would substantially expand Peace Arch's library of proprietary film and television titles, create one of the strongest independent feature film sales companies in the business, it will make Peace Arch one of the top international suppliers of high quality television programming and result in one of the largest independent DVD distributors in North America.
