(1) The shares of phantom stock relate to shares of stock granted under the Cleco Corporation Long-Term Incentive Compensation Plan. No separate value was exchanged for these shares. The reporting person has elected to defer receipt of these shares of stock under the Cleco Corporation Deferred Compensation Plan (the "Plan"). Each share of phantom stock is the economic equivalent of one share of Cleco Corporation common stock.

(2) Includes 13,599 shares of phantom stock (not subject to restrictions) related to dividend reinvestment on shares of phantom stock awarded pursuant to the terms and provisions of the Plan.
