- (4) Pursuant to the achievement of certain objective, performance-based criteria, none of the phantom units eligible to vest for the year ended December 31, 2014, granted on February 2, 2012 and March 7, 2013, vested and therefore 7,428 phantom units were forfeited. With respect to the subjective phantom unit grants, 1,599 phantom units (the third tranche of the 2012 subjective phantom unit grant) and 2,702 phantom units (the second tranche of the 2013 subjective phantom unit grant), vested.
