Rather, this amount represents shares withheld by the Issuer for the payment of certain withholding taxes due upon the 3/15/15 vesting of 65,703 of the 328,515 shares of restricted stock that Mr. Delpani was granted (1) on 8/6/14, pursuant to the terms of the Fourth Amended and Restated Revlon, Inc. Stock Plan. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares. The remaining restricted shares granted to Mr. Delpani are scheduled to vest in equal installments on 3/15/16, 3/15/17, 3/15/18 and 3/15/19, subject to certain terms and conditions.
