SCHEDULE 13D

This Amendment No. 1 to Schedule 13D ("Amendment No. 1") amends and supplements the Schedule 13D originally filed with the Securities and Exchange Commission (the "Commission") on August 25, 2017 (the "Schedule 13D") relating to the common stock, par value \$0.001 per share (the "Common Stock"), of Issuer Direct Corporation, a Delaware corporation (the "Issuer"). Unless otherwise indicated, all capitalized terms in this Amendment No. 1 have the meanings set forth for such terms in the Schedule 13D. This Amendment No. 1 amends and supplements the Schedule 13D to include the information set forth below. Except as specifically provided herein, this Amendment No. 1 does not supplement, restate, amend or modify any of the information previously reported in the Schedule 13D.

Item 5. Interest in Securities of the Issuer

Item 5(a), (b) and (c) are hereby amended and restated in their entirety with the following:

(a) EQS Group AG is deemed to have voting and dispositive power with respect to 241,916 shares of Common Stock of the Issuer, representing approximately 8.19% of the 2,954,092 shares of Common Stock issued and outstanding. The issued and outstanding shares of the Issuer's Common Stock referenced in the preceding sentence are as of August 7, 2017, as reported in the Issuer's Definitive Proxy Statement on Schedule 14A, filed with the Commission on August 7, 2017.

(b) EQS Group AG is deemed to have sole voting power and sole dispositive with respect to 241,916 shares of the Issuer's Common Stock.

(c) During the past 60 days, EQS Group AG acquired beneficial ownership of 145,839 shares of the Issuer's Common Stock through acquisitions made between July 19, 2017 and September 8, 2017 on the open market at prices ranging from \$12.10 per share to \$12.60 per share (exclusive of any fees, commissions or other expenses). Transactions in the Common Stock effected by the Reporting Persons since the filing of Schedule 13D are set forth on Schedule A to this Amendment No. 1. All of the transactions reflected in Schedule A to this Amendment No. 1 were effected in open market transactions on the NYSE American Stock Market and other market places in the ordinary course of the Reporting Person's business. Upon request, the Reporting Person hereby undertakes to provide to the Issuer, any stockholder of the Issuer, or the Staff of the Commission, full information regarding the number of shares of the Issuer's Common Stock purchased and the prices of each trade within the ranges set forth in this Item 5(c).

Except as set forth in Schedule A to this Amendment No. 1, neither EQS Group AG, nor any person listed on Schedule I to the Schedule 13D, has effected any transactions in the Issuer's Common Stock since the filing of the original Schedule 13D.
