(1) Represents the sale of 9,700 shares in 30 separate transactions, ranging from \$71.18 to \$71.60 per share, resulting in a weighted average sale price per share of \$71.390. The Reporting Person undertakes to provide upon request by the SEC staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares sold at each separate price within the range.

(2) Represents the sale of 300 shares in 2 separate transactions, ranging from \$72.50 to \$72.53 per share, resulting in a weighted average sale price per share of \$72.520.
