 This restricted stock was granted pursuant to the Issuer's 2009 Performance Incentive Plan. The Reporting Person's interests in the Restricted Stock will vest pursuant to the vesting schedule set forth in the Restricted Stock Agreement dated March 8, 2012. Pursuant to the Agreement, 38,176 total shares will vest by the passage of time ("Time Vested Shares") and 19,089 shares will vest pursuant to certain performance criteria ("Performance Vested Shares") in four annual installments commencing December 31, 2012 through December 31, 2015.
