**Item 1.01. Entry into a Material Definitive Agreement.**

On October 31, 2013, Golub Capital BDC Funding LLC (“Funding”), a wholly owned subsidiary of Golub Capital BDC, Inc. (the “Company”), entered into an amendment (the “Credit Facility Amendment”) to the documents governing Funding’s senior secured revolving credit facility (the “Credit Facility”) with the Company, as transferor and as servicer, Wells Fargo Securities, LLC, as administrative agent, and Wells Fargo Bank, N.A., as lender. The Credit Facility Amendment is effective as of October 31, 2013.

The Credit Facility Amendment, among other things, (a) increased the size of the Credit Facility from \$100 million to \$250 million, (b) extended the expiration of the revolving period from November 21, 2013 to October 21, 2014, during which period Funding, subject to certain conditions, may make borrowings under the facility and (c) extended the stated maturity date from October 20, 2017 to October 22, 2018.

As previously disclosed, the Credit Facility is secured by all of the assets held by Funding, and the Company has pledged its interests in Funding as collateral to Wells Fargo Bank, N.A., as the collateral agent, to secure the obligations of the Company as the transferor and servicer under the Credit Facility. Borrowing under the Credit Facility remains subject to the leverage restrictions contained in the Investment Company Act of 1940, as amended.

The description above is only a summary of the material provisions of the Credit Facility Amendment and is qualified in its entirety by reference to a copy of the Credit Facility Amendment, which is filed as Exhibit 10.1 to this current report on Form 8-K.
