Yorkville IM is the investment manager to YA Global and YA II, and in such capacity may be deemed to beneficially own 169,058 Ordinary Shares, the same number of Ordinary Shares as beneficially owned by YA Global. Yorkville GP is the general partner of Yorkville IM and as such may be deemed to beneficially own the same number of Ordinary Shares beneficially owned by YA Global. Matt Beckman is the Co-Portfolio Manager of Yorkville IM and Yorkville GP and as such may be deemed to beneficially own the same number of Ordinary Shares beneficially owned by YA Global.
