AMENDMENT NO. 2 TO SCHEDULE 13D

This Amendment No. 2, dated March 20, 2008, amends Schedule 13D as previously filed by the Reporting Persons with the Securities and Exchange Commission on August 14, 2007 (the "Schedule 13D"), relating to the Common Stock, par value \$0.0001 per share, of American Community Newspapers, Inc. a Delaware Corporation.

Items 3 and 5 of the Schedule 13D are hereby amended and restated, as follows:

ITEM 3 SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

As of March 20, 2008, Hummingbird has caused HVF and Microcap Fund to invest approximately \$1,394,591 and \$556,705, respectively, in the Shares of the Issuer using their working capital. Mr. Sonkin has invested approximately \$23,000 in Warrnts of the Issuer, using private funds.

ITEM 5 INTEREST IN SECURITIES OF THE ISSUER

(a) As investment manager of HVF and Microcap Fund, Hummingbird may be deemed to have the sole voting and investment authority over the Shares owned by HVF and Microcap Fund for purposes of Rule 13d-3 under the Securities Exchange Act of 1934, as amended ("Rule 13d-3"), may be deemed to be the beneficial owner of 403,903 Shares representing approximately 2.8% of the outstanding Shares of the Issuer (based upon 14,623,445 Shares outstanding as

of November 14, 2007, as reported in company's 10-Q filing for the period ending September 30, 2007.) Hummingbird disclaims any beneficial ownership of the Shares covered by this Statement.

Mr. Sonkin, as the managing member and control person of Hummingbird, may be deemed to have the sole voting and investment authority over the Shares beneficially owned by Hummingbird and, for purposes of Rule 13d-3, may be deemed to be the beneficial owner of 403,903 Shares representing approximately 2.8% of the outstanding Shares of the Issuer (based upon 14,623,445 Shares outstanding as of November 14, 2007, as reported in company's 10-Q filing for the period ending September 30, 2007.) Mr. Sonkin disclaims any beneficial ownership of the Shares covered by this Statement. In addition, Mr. Sonkin owns 50,000 Warrants in his brokerage Accounts, which have not yet been exercised or converted.
