(1) On August 19, 2011, an aggregate of 4,730 restricted shares previously issued to Mr. Milroy vested in accordance with their terms and the terms of the plan under which such shares were issued. Mr. Milroy elected to withhold an aggregate of 1,547 shares to pay the related taxes. As such, the number of shares actually issued was 3,183.

(2) On August 20, 2011, an aggregate of 5,000 restricted shares previously issued to Mr. Milroy vested in accordance with their terms and the terms of the plan under which such shares were issued.
