On May 31, 2012, the Reporting Person was awarded a total of 11,485 restricted shares of Common Stock of iStar Financial Inc. (SFI) in accordance with the provisions of the iStar Financial Inc. Non-Employee Directors' Deferral Plan ("Plan"). These shares are restricted and

- (1) may not be sold or otherwise transferred prior to May 31, 2013. Previously, on February 8, 2011, pursuant to a final divorce decree and property settlement, the Reporting Person transferred 18,550 shares of Common Stock to his former spouse. The Reporting Person is currently the beneficial owner of a total of 111,723 shares of Common Stock, which are owned indirectly through a partnership.
- The Reporting Person also holds a total of 43,591 Common Stock Equivalents (CSEs) awarded pursuant to the Plan, all of which are vested. Under the Plan, on the regular distribution date, vested CSEs will be settled by the transfer of shares of iStar Common Stock to the participant. The "regular distribution date" for distributions to Plan participants is the earlier of: (1) January 1 on or next following the earlier of (i) the date the participant ceases to be a non-employee director; and (ii) the date of the participant's death; and (2) a change of control (as defined in the Plan). A participant, under certain limited circumstances, is permitted to elect to receive distributions at times other than the regular distribution date.
