The reporting person will receive from NRG Energy, Inc. one such share of Common Stock for each Deferred Stock Unit he owns upon the following schedule: (i) 25% on 1/15/21; (ii) 25% on 1/15/22; (iii) 25% on 1/15/23; and (iv) 25% on 1/15/24. The dividend equivalent rights accrued on the reporting person's deferred stock units which they have received. Each dividend equivalent right is the economic equivalent of one share of NRG common stock.
