## Explanation of Responses:

- (1) Reflects the issuance of CUB common stock upon vesting of restricted stock units ("RSUs"). Each RSU granted at that time represented a contingent right to receive one share of CUB stock.
  - (2) Shares withheld by CUB to satisfy the minimum statutory tax withholding obligations that arose upon the vesting of the RSUs.
  - (3) Represents shares held in Harrison Living Trust 2008, a trust for which Reporting Person and his spouse are co-trustees with full voting and dispositive rights.
  - (4) Represents shares held by the Reporting Person's 401(k).
  - (5) This is the fourth and final of 4 vesting installments of RSU's granted to the Reporting Person on November 6, 2014.  
This is the third of 4 vesting installments of RSUs granted to the Reporting Person on November 6, 2015. The remaining 819 shares from
  - (6) such grant shall vest in 1 final installment on October 1, 2019, subject to the Reporting Person's continuous service through such application vesting date.  
This is the second of 4 vesting installments of RSUs granted to the Reporting Person on November 14, 2016. The remaining 1628 shares
  - (7) from such grant shall vest in 2 equal installments on October 1, 2019 and 2020, subject to the Reporting Person's continuous service through each application vesting date.  
This is the second of 4 vesting installments of RSUs granted to the Reporting Person on July 17, 2017. The remaining 1056 shares from
  - (8) such grant shall vest in 2 equal installments on October 1, 2019 and 2020, subject to the Reporting Person's continuous service through each application vesting date.  
This is the first of 4 vesting installments of RSU's granted to the Reporting Person on November 27, 2017. The remaining 1832 shares
  - (9) from such grant shall vest in 3 equal installments on October 1, 2019, 2020 and 2021, subject to the Reporting Person's continuous service through each application vesting date.
