Item 8.01 Other Events.

On April 20, 2013, Clean Coal Technologies, Inc. (the "Company") entered into a settlement agreement ("Settlement") with AGPL Investments Pte. Ltd. ("AGPL") which includes mutual termination of all agreements between the parties and mutual releases of claims relating to the Joint Venture Agreement dated May 31, 2012, the Exclusive Technology License Agreement, the Heads of Terms Agreement dated March 13, 2012, and the EPC Payment Agreement dated

September 21, 2012. The Settlement also calls for the immediate closure and dissolution of Good Coal Pte Limited, Singapore (“Good Coal”), as well as the release by AGPL and Good Coal of any and all rights under any of the agreements between the Company, AGPL and Good Coal, and mutual releases by the Company and AGPL of any damage claims against each other. AGPL has also granted the Company a 60 day option to purchase the 48,528,082 shares of the Company’s common stock held by AGPL at a price of \$0.05 per share.

The Company previously announced the termination of its agreements with AGPL in its Current Report on Form 8-K filed December 24, 2012.
